RESEARCH LINES

CONSTITUTION, LEGAL ORDER AND PUBLIC ADMINISTRATION

Contemporary transformations in the field of organization and functions of public power and legal order, have had as main objectives the constitutional supremacy and constitutionalization of Law as fundament for the effective rule of Law in its most current connotations. All this movement has had as core topic the strengthening of the legal position of individuals and its rights in relation with the State and other organized forms of public power. On this regard, the purest accomplishment of the human condition, on the most individualistic dimension as well as on the social one, requires the improvement of the legal system, a due regulation of legal relationships and respect of public acts on constitutional mandate and other legal provisions, as well as the values and principles that informs the legal order.

On this regard, we propose the following research topics:

- Public power and Law under a historical perspective.
- Constitution, democracy and rule of Law.
- Constitution and public power.
- Constitution, rights and guarantees.
- Constitutionalization of Law and the different fields of the legal order.
- Justice and the challenges of constitutional order.
- Constitutional supremacy and constitutional defense.
- Theoretical and philosophical problems of the legal order.
- Public administration and Constitution.
- Current fundamentals of the legal regime of Public Administration.
- Guarantees vs. functions of the Public Administration.
- The form of administrative acts on the light of the current legal order.
- Challenges of Municipality on the current legal order.
- Environment, Constitution and legal order.
- Principles of Law: projections and reality in the legal order.

RESEARCH LINES

INDIVIDUALS, FAMILIES, AND VULNERABILITIES FROM THE PERSPECTIVE OF LAW

Vulnerabilities are becoming one of the most outstanding institutions in civil and family Law, taking into account that its subjects could be victims of social exclusion. The protection of rights of persons living with any kind of vulnerability is a constitutional challenge the private Law cannot take away from the main focus. Civil Law has paid special attention to individuals and Family Law -in a more social vocation-, sets norms for the different family arrangement that persons can construct and becomes essential source of legal tools that pretend to solve the asymmetries that vulnerabilities create between persons.

On this path we propose the next research topics:

- Hyper-vulnerable consumer in Cuban Law.
- Population aging phenomenon, public policies, and private financing of elderhood. Legal instruments.
- Human persons on the center of attention of civil Law.
- Vulnerable subjects in Family Law: legal instruments for the protection of rights.
- Social function of the hereditary reserved portion: protection of persons in situation of economic vulnerability.
- Family plurality in the new family Law.
- Susceptible borrower in credit relations.

JURISDICTIONAL PROTECTION OF PERSONAL AND FAMILY RIGHTS

The Code of Processes is an answer to the constitutional mandate of development and guarantee of rights; but, at the moment of its entrance into force it did not have an updated substantive norm. This situation imposed great challenges to academicians and professionals of law facing the effective protection of personal and family rights. The Code of Families, with great transcendence in the civil field, demands the use of innovative tools for legal processes.

In this regard we evoke the following lines for investigation:

- Justice of accompaniment and judicial powers.
- Reasonable adjustments as materialization of effective equality.
- Precautionary measures as expression of an expedited rights safeguarding.
- Procedural modalities at the service of individuals and families.

RESEARCH LINES

CRIMINAL AND CRIMINOLOGICAL ISSUES

Conventional and non-conventional delinquency represents one of the essential challenges while facing and preventing crime and deviant behavior in the Cuban Society. Therefore, the main concerns emerge not only from the implementation of legal reforms already made, but they also require due studies for advanced investigation, interpretation and application of postulates from the Constitution of the Republic of Cuba of 2019 to the criminal substantive regulations and criminal procedural norms.

In this sense we propose as investigation lines:

- Challenges of the substantive and procedural criminal reforms in Cuba.
- Gender and Criminal Law.
- Non-conventional delinquency and its manifestation in Cuba.
- Crimes against Humanity and Cuban Criminal Code.
- Delinquency prevention and deviant conduct. A multidisciplinary overview.
- Treatment to age issues in the substantive and procedural criminal reform in Cuba.
- Social control agencies in prevention and fight against crime.

FORENSIC SCIENCES AND ITS CONTRIBUTION TO CRIMINOLOGY

Forensic Sciences, as contributor to Criminal Law and Criminology aid in the investigation of acts qualified as crime, which represent a special grip in the Cuban procedural reform. It allows the continuous enhancement, of the investigation of criminal conducts and provides the elements for its prevention:

- Criminal investigation in Cuban contemporary environment.
- · Special and traditional research techniques in Cuban criminal processes.
- · Advances of Criminalistic Sciences in crime prevention.

EJES TEMÁTICOS

GLOBALIZACIÓN Y DERECHO INTERNACIONAL

International Law has been strengthening different spaces to confront and overcome dynamics that unleashes world wars. Peace has become the core of international relations. In first place, after the acceptance of the principles of no use of force and peaceful conflicts settlement in the Charter of the United Nations. Even though the impact of globalization and the use of ICTs, has substantially amplified study fields for modern and public international law.

The Human rights, international protection of the environment, right to development, have been a core part to establish objectives and goals for sustainable development and it has compromised in a certain way all States in the International Community. This is an expression of the gradual conviction al States that there is no possible existence of international law without mechanisms to guarantee its effectiveness. We need to take into account this conception is based primarily in the fulfilment with good faith of all international regulation and the creation of diversified mechanisms in search of effectivity is a useful and necessary complement that gives international law a greater importance.

In this order we propose the following research topics:

- The emerging sources of International Public Law and international coercibility.
- Impact of the Soft Law in International Public Law. Analysis from the perspective of Economic International Law, International Law of Environment Protection and International Labor Law.
- International protection of Human Rights.
- Right to development in the multilateral system of commerce.
- Law of the Sea and its systemic impact in globalized international relations.
- International disputes settlement. Analysis of the role of international arbitration in the preservation of world peace.
- International cooperation.

BUSINESS LAW

Despite the different economic systems at international levels, business law has central postulates, which are objects of analysis and reevaluation in different countries through the processes of economic integration at international level, interconnection between the existent economic models, public-private associations in worldwide opening processes, new perspectives civil contracts, commercial and administrative regulations, the role of tributes and financial mechanisms in the economy of several countries, labor rights and its main guarantees, methods and dispute settlements mechanisms in the field of commercial and labor law, at a national and international level.

According to these facts, we propose a list of research topics as follows:

- Content and analysis of Economic Constitutions.
- Legal forms of organization of different subjects of the economy. Current tendencies of its organization, functioning and management: cooperatives, public enterprises.
- Foreign investment: promotion and guarantees.

- Legal public/private associations. Organization, functioning, benefits and controlling.
- Contracts in civil/commercial/administrative issues: lights and shadows. New regulations in the international arena.
- Dispute settlement in labor and commercial conflicts at a national and international level. The use of alternatives methods of dispute settlement.
- International business law.
- Protection of science, technology, and innovation: organizational forms in university bondage with business environment. Intellectual property as a form of protection of immaterial creation at a national and international level.
- International commerce of merchandise and services.
- Insolvency of assets for entrepreneurs. Experiences of its regulation at an international level.
- Financial activity and Law: justice and inclusion.
- Labor rights and economic development.
- Decent work and new forms of employment.

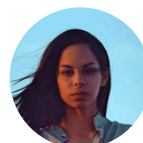
