SUBMISSION, PRESENTATION AND PUBLICATION GUIDELINES

Abstracts will be uploaded to the Convention website during registration, in word format, in a single paragraph with no more than 250 words, excluding title and affiliation.

Title: in bold letters

– Authors: name and surname, underlining the author presenting the paper, indicating the presenter's e-mail address and the affiliation of all authors with superscript number after the name, and including each institution of origin below.

- Structure of the abstract: background, objectives, results, and conclusions.

All papers will be subjected to a review process by the Scientific Committee of every event, which will decide upon the acceptance and the way papers will be presented: oral or poster.

The selected papers may be published in the journals of the University of Havana according to the topics of the event (information on the web) and following its guidelines.
